



AGC Vision Line 120 by McGrory is a butt-glazed, fire-rated system for interior, 2-hour transparent walls utilizing Pyrobel[®] 120, a low-iron and impact-safety fire-resistant glass. Tested and rated without the requirement of bulky or expensive framing, the system can be rapidly deployed while meeting aesthetic and budgetary requirements.

- ♥ I20-Minute, 250°F temperature rise transparent wall system
- Continuous walls with an unlimited number of glass panels with sizes up to 40" x 114" or 114" x 40" (4560in²)*
- Narrow 4mm vertical joints for maximum transparency
- Low-iron, multi-ply laminated glazing with 84% visible light transmission and 48 STC

NOTE: AGC Vision Line 120 by McGrory complies with ASTM E119, UL 263, and CAN/ULC S101 fire-resistive standards.





GLAZING DETAIL

Fire-Resistive Non-Bearing Wall - 120 Minute Rating



I. FIRE RESISTANT GLAZING MATERIAL - Pyrobel 120-53N or 120-53NEG by McGrory Glass. Multi-ply, low-iron laminated glass totaling a thickness of 53 – 57mm (+/- 3mm), glazed into non-load bearing fire-rated wall construction.

2. GLAZING STOPS – Steel L-Angle Perimeter Channel. Minimum 1" wide \times 1" tall \times 1/8" thick steel angle, anchored with minimum #6 \times 1" fasteners spaced 8" on center, starting 2" from each end. Stops may be discontinuous/spliced; butt-joints of stops must be offset from the butt-joints of the glazing panels by minimum of 6".

3. SETTING BLOCKS – Calcium Silicate. Minimum of (2) 1" wide \times 1/4" tall \times 3" long setting blocks per glazing panel; each located at the quarter point.



4. GLAZING TAPE – Close Cell PVC. Minimum 1/8" thickness. Applied to glazing stop with either single strip or two (2) 1/2" strips applied for total 1" width of tape covering the glass-side of the stop.

5. WALL CONSTRUCTION – Gypsum/Studded or Masonry Fire-Rated Wall. Gypsum Association File # WP 1206 or any similar 1 hr fire-rated wall design with steel stud and track or wood stud wall with 1 layer on 5/8" sheetrock on each face. Rough opening must be double studded. Masonry walls of equal rating are permitted.

6. STOP COVER – Gypsum Wallboard. Two layers of minimum 1/2" thick, type C or X. Affixed by 2-1/2" drywall screws or fire-rated adhesive. Optional: Stop covers may be concealed with a decorative finish with a flash point greater than 400°F.

7. SILICONE SEALANT – 100% Neutral-Cure Silicone. Silicone bead applied at seam between stop cover and glass, continuously applied around perimeter on both sides of the opening



Butt-Joint Detail

8a. GLAZING TAPE – Kerafix 2000/Superwool X607. Intumescent glazing tape, 4-5mm wide x 3mm thick (uncompressed). Single strip affixed to center of butt-joint prepped edge.

8b. GLAZING TAPE – Kerafix FXL 200. Intumescent glazing tape, maximum 10mm wide x 2mm thick. Affixed adjacent to both sides of item 8a.

8c. SILICONE SEALANT – DOWSIL 795 or Firestop 700. 100% Neutral-cure silicone glazing infill compatible with AGC Pyrobel.

Note: Glazing panels cannot be stacked one on top of another. Note: Glazing panels are not to be considered a structural support for the fire rated wall. *Installation design may vary depending on the size of panel(s) required for project.
